

Terms and conditions of Stuttgart Festival of Animated Film

Festival badges and accreditations

1. Festival badges and accreditations are personalized, non-transferable and cannot be replaced.
2. Once bought, the fees already paid for festival badges and accreditations cannot be cancelled or refunded.
3. Festival badges and accreditations grant access to all events of the Stuttgart Festival of Animated Film according to availability of free places. Excluded are special events that are invite-only.
4. Seating capacities are limited by fire regulations. Seating reservations are not possible. For holders of festival badges and accreditations a limited number of seats will be kept free until 15min before the event.
5. Students are obliged to show their valid student card when picking up a reduced student accreditation.

Photography, film and audio recordings/privacy policy

1. Film and audio recordings are forbidden during all film screening and events. In case of violation, we reserve the right to withdraw accreditations or festival badges, to confiscate the recordings and/or to ban the participant from the event.
2. The Stuttgart Festival of Animated Film employs a professional photographer during the event and reserves the right to use all images that the photographer takes for promotion and publication purposes.
3. Some events of the Stuttgart Festival of Animated Film are filmed from a camera crew for documentation purposes. Furthermore, these recordings will be published for promotion and publication purposes.

Use of personal data

1. All data collected with the purchase will be used exclusively for the generation of festival passes and accreditations, for statistical surveys as well as for information purpose as described in item 2. This data will not be passed on to third parties (except Xing and ITFS).
2. By purchasing a ticket via Xing-events, every buyer accepts to be published in a list of participants on the ITFS-website and in the ticket shop (Xing-Events) with the following data: title, first name and surname.
3. Besides, every buyer agrees to be published on the list of accredited participants during the event period (April 30 – May 5, 2019) with the following data: first name, surname, company. This list is located at the ITFS information counter and can be consulted.
